

TOURISM PRINCE GEORGE CONTEST RULES

TERMS AND CONDITIONS

Entry exists solely online and consists of the following:

- Enter on our website at <https://tourismpg.com/staycations/>, then submit a photo of yourself and a friend using the #explorePrinceGeorge through the “Yes I want to Win” button on the Staycations page.

Contest begins at 9:00am PST on Monday September 28, 2020 and ends at 8:30 AM PST on December 15, 2020.

One prize winner drawn every month.

No purchase or payment necessary to enter or win.

ELIGIBILITY

All Canadian residents, except for those living in Quebec, are eligible to enter unless they are:

- a) an employee, representative or agent of Tourism Prince George or
- b) an immediate family member of an employee.

At any time, Tourism Prince George reserves the right to request from any individual who has participated in the Contest by submitting an Entry, proof of identity and/or eligibility to participate. Failure to provide proof within a reasonable time or the provision of false or misleading information could result in the Entrant's disqualification. Contest is subject to all applicable federal, provincial, territorial and local laws and regulations.
